WHAT IS A STUDENT TRUSTEE?

In the spring of 1998, Governor Gary Locke signed into law a bill allowing students at four-year colleges and universities in the State of Washington to have voting member privileges on their respective Board of Trustees.

RCW 28B.40.100 Trustees--Appointment—Terms—Quorum—Vacancies

- (1) The governance of The Evergreen State College shall be vested in a board of trustees consisting of eight members, one of whom shall be a <u>student</u>. The governor shall select the <u>student</u> member from a list of candidates, of at least three and not more than five, submitted by the <u>student</u> body. They shall be appointed by the governor with the consent of the senate and, except for the <u>student</u> member, shall hold their offices for a term of six years from the first day of October and until their successors are appointed and qualified. The <u>student</u> member shall hold his or her office for a term of one year from the first day of June and until his or her successor is appointed and qualified. The <u>student</u> member shall be a full-time student in good standing at the college at the time of appointment.
- (2) Five members of the board constitute a quorum for the transaction of business. In case of a vacancy, or when an appointment is made after the date of expiration of the term, the governor shall fill the vacancy for the remainder of the term of the <u>trustee</u> whose office has become vacant or expired.
- (3) Except for the term of the <u>student</u> member, no more than the terms of two members shall expire simultaneously on the last day of September in any one year.
- (4) A <u>student</u> appointed under this section shall excuse himself or herself from participation or voting on matters relating to the hiring, discipline, or tenure of faculty members and personnel.
