The WDFW is recruiting to fill one full time permanent Fish & Wildlife Biologist 3 position located in the Habitat Program. This position reports to the Regional Habitat Program Manager and serves as the lead for the Program regarding fish & wildlife habitat preservation, protection, conservation, restoration, enhancement, and environmental permitting requirements in Chelan and Douglas counties. The position is also responsible for providing technical assistance regarding fish and wildlife habitats both internally as a member of the District Team and within the community assigned, including state agencies, local governments, tribal governments, members of the public and conservation groups. The duty station is the WDFW Region 2 District Office in Wenatchee, Washington in Chelan County.

DUTIES:

Serves as Department expert in Chelan and Douglas County regarding Fish & Wildlife habitat preservation, protection, conservation, restoration, enhancement, and environmental permitting requirements.

Implements the Hydraulic Project Approval process in accordance with Chapter 77.55.RCW, 77.57.RCW, and Chapter 220-110-WAC (Hydraulic Code Rules).

Participates in the update of data and management plans for the Department Priority and Species Habitat Program.

Provides office and field review and assistance regarding County or City environmental protection ordinance implementation under the Shoreline Management Act and Growth Management Act.

Serves as lead for forest habitats by providing office and field review of plans, permits and actions conducted in the forested environment.

Participates in the development of fish habitat restoration projects as lead or part of a multidisciplinary team. This can include grant-writing, formal presentations, and project development/management.

QUALIFICATIONS:

This position requires a bachelor's degree in fisheries, wildlife management, ecology, natural resource science, or environmental science and three years of experience in fish, wildlife, or habitat management or research. A master's or Ph.D. with a relevant specialty may substitute for one year of the experience.

The best qualified applicants will have experience and training that demonstrate knowledge, skills, and abilities in the following areas:

- Knowledge of Pacific Northwest fish and wildlife, their habitats and life histories.
- Demonstrated knowledge and working experience in habitat restoration, protection, conservation and restoration methods, techniques and strategies.
- Working knowledge of fish and wildlife inventory and/or habitat assessment techniques.
- Demonstrated ability to effectively work with the public, tribes and other government entities on difficult or sensitive environmental issues.
- General knowledge of state and federal environmental rules and regulations in Washington State.
- Ability to use Microsoft Office 2007 products especially WORD and EXCEL; working knowledge of the use and application of Priority Habitats and Species databases is desirable;
- Ability to use ARCGIS or other similar programs;
- Ability to effectively negotiate agreements as a representative of the agency; ability to mediate/resolve conflicts involving difficult or sensitive issues;
- Ability to communicate effectively in writing and orally.
- Ability to deliver responsive and professional customer service to applicants, citizens, stakeholders, local governments, tribes, and state and federal agencies.

Experience is based on full time equivalency (i.e., 40 or more hours/week). Part time work is prorated (e.g., 20 hours/week for 6 years = 3 years of experience). Do not count experience that was a part of your educational requirements.

Working Conditions

Typical hours are 8:00 am to 5:00 pm. Early morning or late evening work may occasionally be required with the potential to be called for emergency response at any time. Occasional overnight travel may be required. Field work can vary from 10% to 80% depending upon

season and requires working outdoors during inclement weather, walking over rough terrain (typically less than a mile but occasionally over long distances of several miles) while carrying a light load. Field work may involve wading in moving water while operating a backpack electroshocker and/or operation of a boat in riverine or lake environments.
