#### **DUTIES:**

Assist with various fish culture duties and perform hatchery related maintenance. Tasks and job conditions include:

## Weir maintenance:

Maintains the lower river weir. Removes debris/leaves, regulates weir heights and performs minor repairs. The task requires in-stream work on unstable terrain and repetitive raking.

# Adult fish handling:

Collecting, sorting, spawing, sampling of adult salmon. These duties require heavy, repetitive lifting of adult transport boots and working within the river, in rearing ponds and under foul weather.

#### Data collection and recording:

Observe and record weir operating times and fish behavior in a clear and professional format.

## **Working Conditions:**

Typical work schedule is 8- 4:30 Sunday - Saturday, with a schedule of 10 days on and 4 days off and the 1st 7 days will be pulling standby. Depending on time of year; includes days, nights, weekends, and holidays as needed. This position also requires you to work alone or with others in remote locations. Working outside in adverse weather conditions and perform strenuous physical activities. This position requires a valid driver's license. (If selected for an interview, you may be asked to furnish your license and driving record.) **Standby has been assigned and a travel trailer is available to facilitate the standby requirement.** 

#### QUALIFICATIONS:

Requires meeting the minimum requirements of a Fish Hatchery Technician: Graduation from high school or GED. **Hatchery work experience is desired.**
